

I am directed to state that the Executive Committee of the DCI at its meeting held on 11<sup>th</sup> July, 2019 at New Delhi considered letter No.MRIIRS/Acad./2019/196 dated 24.6.2019 received from the Registrar, Manav Rachna International Institute of Research & Studies (Deemed to be University), Faridabad, Haryana thereby stating that the notification issued by the Ministry of Human Resources Development (MHRD), Department of Higher Education, ICR Division, Govt. of India, New Delhi vide No: F-10/2016-U3 (A) dated 13.5.2019 with regard to the approval for inclusion of Manav Rachna Dental College, Faridabad under the ambit of Manav Rachna International Institute of Research & Studies (Deemed to be University), Faridabad as Constituent Institution w.e.f the date of disaffiliation from its affiliating University i.e. Pandit Bhagwat Dayal Sharma University of Health Sciences, Rohtak, Haryana and also informing that in pursuance to notification of MHRD and "No Objection Certificate" issued by the Medical Education and Research Department, Govt of Haryana, the Pandit Bhagwat Dayal Sharma University of Health Sciences, Rohtak, Haryana vide letter No UHSR/A-II/2019/3700-3718 dated 14.6.2019 has disaffiliation Manav Rachna Dental College, Faridabad for affiliation with Manav Rachna International Institute of Research & Studies (Deemed to be University), Faridabad as a Constituent Institution w.e.f the date of disaffiliation. Accordingly, Manav Rachna Dental College, Faridabad has now become a Constituent Institution of Manav Rachna International Institute of Research & Studies (Deemed to be University), Faridabad w.e.f. 14.6.2019 for all intents and purpose and after discussion & deliberation decided as under:

The college authority be asked to approach immediately to the Govt. of India for change of university from Pandit Bhagwat Dayal Sharma University of Health Sciences, Rohtak, Haryana to Manav Rachna International Institute of Research & Studies (Deemed to be University), Faridabad alongwith the necessary documents.
